March 2025 Financials

April 22, 2025 Finance Committee Minutes

Jenny Abbs presented the financial report to the board. As regularly practiced, the board reviewed the March 2025 financial reports including the balance sheet, summary of revenue and expense statements, cash flow and check register. Ryan Nelson presented a motion to accept the March 2025 Financials and the April 22, 2025 Finance Committee Minutes. Motion was seconded by Bart Jones. Motion passed unanimously.

#### FY26 Budget and 16 month cashflow

Jenny Abbs presented the proposed FY26 budget to the board. The budget is based on 850 ADM. Compensatory Revenue has dropped by \$500,000 due to a legislative change that only direct cert students are now eligible. Athlos has more students who qualify via paper free and reduced forms which will no longer be included in the calculations for Compensatory Revenue. Two

percent staff increases are built into this budget. The building lease amount is set per our bond payment schedule. The refinancing opportunity savings have been conservatively built into this budget at \$100k rent reduction. Final savings will not be known until after the closing. Summer programming will not happen this year due to ESSER funding expiring. The budget assumes a net income of \$117,804 in all funds. This result will bring our fund balance to \$3,678,277 at the end of FY26, or 26% of total expenditures. All Bond Covenant metrics will be met. Ryan Nelson presented a motion to approve the FY26 budget and 16 month cashflow. Motion was seconded by Caroline Walker. Motion passed unanimously.
